

## **EQUINE ACTIVITY RELEASE OF LIABILITY WAIVER**

**This Release of Liability (the "Release") is entered into by the undersigned horse owner (the "Owner") and [Tonya Ballman Lakewolf/Pinedrop Ponies] (the "Trainer"), including its agents, employees, contractors, and affiliates.**

### **1. Assumption of Risk**

The Owner acknowledges that working with horses and equine training activities are inherently dangerous and involve risks of injury, death, or property damage. These risks include, but are not limited to, the behavior and actions of horses, the possibility of being thrown or injured by a horse, accidents involving equipment or other people, and unpredictable animal behavior. The Owner voluntarily assumes all risks associated with the training services provided by the Trainer.

### **2. Release of Liability**

In consideration of allowing the Trainer to work with the Owner's horse(s), the Owner, for themselves, their heirs, executors, administrators, and assigns, hereby fully and irrevocably releases, waives, discharges, and covenants not to sue the Trainer, its agents, employees, contractors, and affiliates for any and all liability, loss, damage, injury, or death to the Owner, the Owner's horse(s), or any third parties arising out of, or in connection with, the training services provided, including but not limited to claims arising from the negligence of the Trainer or any other person acting on behalf of the Trainer.

### **3. Indemnification**

The Owner agrees to indemnify and hold harmless the Trainer from any and all claims, demands, causes of action, or judgments arising from the training services, including any injury, damage, or loss that may occur to the Owner, their horse(s), or any third party as a result of the Owner's horse(s) during training, or the Owner's actions while involved with the training.

### **4. Health and Safety of the Horse(s)**

The Owner represents that their horse(s) is in good health and free of any contagious diseases or injuries that may pose a risk to other animals or people. The Owner agrees to provide the Trainer with all relevant medical information regarding the horse(s), including vaccination records, previous injuries, or any behavioral issues that may affect training.

### **5. Veterinary Care Authorization**

In the event of an emergency, the Owner authorizes the Trainer to seek immediate veterinary care for the Owner's horse(s) at the Owner's expense, if necessary. The Owner agrees to reimburse the Trainer for any veterinary costs incurred as a result of emergency treatment.

### **6. No Guarantee of Results**

The Owner acknowledges that the Trainer cannot guarantee specific results from the training services and that success depends on the individual horse, the training methods employed, and the cooperation of the Owner and horse. The Trainer makes no representations or warranties regarding the outcome of the training process.

### **7. Governing Law**

This Release shall be governed by the laws of the state of Washington, specifically Spokane County. Any legal action arising from this Release or related to the training services shall be brought in the state or federal courts located in Spokane County, Washington.

## 8. Entire Agreement

This Release constitutes the entire agreement between the Owner and the Trainer regarding the subject matter herein. No oral representations or prior written material shall be incorporated into this agreement. If any provision of this Release is determined to be invalid or unenforceable, the remaining provisions shall remain in effect.

## 9. Acknowledgment of Understanding

I, the undersigned Owner, have carefully read and fully understand this entire Release of Liability. I understand the risks involved in training horses and voluntarily agree to the terms stated herein. I further acknowledge that by signing this document, I am waiving certain legal rights, including the right to sue the Trainer for any claims arising from the training activities.
